- 1. What skills and experiences qualify you to serve as a Chapter Delegate?

The profession needs to monitor student outcomes as they navigate a post virtual learning environment, and we need to evaluate what are essential skills and how are they best learned- by varied types of learners. Perhaps we can find ways to prepare our students and offer more affordable educational models that help address student debt as a silver lining to the COVID-19 experience. Perhaps we can learn how to practice smarter in our clinics and achieve more lasting health behavior change with telehealth and e-visit opportunities. But the profession needs to be prepared to assess these outcomes.

The House continues to see motions related to **health promotion**; digital technologies, maternal patients/clients, non-pharmacologic management of hypertension, and these represent exciting progress in health promotion by the profession. This is an area I am personally interested in.

Representation within the profession and by the profession to reduce **inequities** based on biases and creating a sense of belonging are of critical importance. I have been involved in Diversity, Equity, Inclusion and Belonging (DEIB) initiatives in my workplace and within the profession and look forward to continuing these efforts.
